

**TERMS & CONDITIONS FOR “BE A CHANGI MILLIONAIRE” PROMOTION
1 MAR 2019 – 29 FEBRUARY 2020**

1. ELIGIBILITY

- 1.1 The "Be a Changi Millionaire" promotion (the "Promotion") comprising such lucky draws specified in these terms and conditions (each a "Lucky Draw", and one or more of them, "Lucky Draws") is organised by Changi Airport Group (Singapore) Pte. Ltd. ("CAG"). It is open to persons aged 18 years and above (as at the date of their participating entry) who meet the minimum spending set out in Clause 2 below, except:
- 1.1.1 directors and employees of CAG and its subsidiaries, the Civil Aviation Authority of Singapore, Wearnes Automotive Pte. Ltd., UnionPay International Co. Ltd. (Singapore Branch), CAG’s appointed agencies which include Ascentis Pte Ltd, Ogilvy & Mather Pte. Ltd., PricewaterhouseCoopers LLP, Texture Media Pte Ltd, Visual Studio (S) Pte Ltd, Arch Vogue Creative Pte Ltd, Hospitality Retail System Marketing Pte Ltd, Diebold Nixdorf Singapore Pte. Ltd., all participating retail partners/shop tenants at Singapore Changi Airport and Jewel Changi Airport and any other persons involved in organising, promoting and/or conducting the Promotion;
 - 1.1.2 immediate family members of persons who fall within the class of persons referred to in Clause 1.1.1 above. Immediate family members mean spouses, children, parents, parents-in-law and siblings;
 - 1.1.3 any person who is or becomes insane, deceased, insolvent or the subject of a criminal investigation, or has criminal proceedings instituted against him/her in any jurisdiction;
 - 1.1.4 any person whose participation in and/or association with the Promotion may cause (in the sole and absolute opinion of CAG) Singapore Changi Airport, CAG and/or the Promotion any disrepute, contempt, scandal, ridicule, or cause Singapore Changi Airport, CAG and/or the Promotion to be perceived unfavourably; or
 - 1.1.5 any other person or class of persons deemed ineligible or notified by CAG as being ineligible from time to time.
- 1.2 CAG reserves the sole and absolute discretion to determine the eligibility of any person in relation to the Lucky Draws, and CAG may at any time before, during or after a Lucky Draw disqualify any person from participating in the Lucky Draws without providing any reason.
- 1.3 Participation in the Lucky Draws is subject to these terms and conditions ("T&Cs"). By participating in any one or more of the Lucky Draws or Instant Game (as defined below), participants agree to be bound by and to comply with the T&Cs, including any amendments, modifications and variations hereto which shall be final and binding in all respects on each participant upon notification and/or publication by CAG.

2. ALLOCATION OF CHANCES IN THE LUCKY DRAWS

- 2.1 Shoppers who spend a minimum of SGD50 in a single receipt at (i) Singapore Changi Airport, Terminals 1, 2, 3 or 4; or (ii) online at www.ishopchangi.com ("iShopChangi"), from 0000hrs on 1 March 2019 to 2359hrs on 29 February 2020 (to qualify, all online purchases made at iShopChangi must be collected by 2359hrs, 29 February 2020) (the "Promotion Period"); or (iii) Jewel Changi Airport from 0000hrs on 1 June 2019 to 2359hrs on 29 February 2020, are eligible to participate in the Lucky Draws for the Weekly Cash Prizes, Car Prize and Grand Prize (as the case may be) (as stated in the two (2) tables below and Clauses 3.1.2, 3.1.3 and 3.1.4 respectively). The number of chances for the Lucky Draws for the Weekly Cash Prize, Car Prize and Grand Prize are allocated as follows:

2.2 In determining the total qualifying spend for the purpose of calculating the number of chances for the Lucky Draws, the net spend will be considered and the following items shall be excluded: -

2.2.1 amounts paid using vouchers (including Changi Dollar Vouchers, Changi Rewards eVouchers and/or Changi Gift Cards); and/or

2.2.2 amounts paid for the purchase of tobacco and/or tobacco products (including without limitation cigarettes, cigars, or any other form of tobacco, any tobacco derivative or substitute, any mixture containing any form of tobacco or a tobacco derivative or tobacco substitute).

2.3 (a) Subject to Clause 2.2 above and save for amounts spent at outlets stated in Clause 2.3(b) below, purchases and/or transactions made at all participating retail, food and beverage (“F&B”) outlets, in both transit and public areas of Singapore Changi Airport (including Arrival Baggage Claim outlets), Jewel Changi Airport and online purchases made at iShopChangi, are eligible to constitute the qualifying spend for the Lucky Draws.

(b) Purchases and/or transactions made at service outlets and at the following outlets at Singapore Changi Airport and Jewel Changi Airport, are **not eligible** to constitute the qualifying spend for the Lucky Draws:

- Banks
- Money changing facilities
- Medical clinics
- Top-up card machines
- Postal services & Post-on-Wheels
- Lounges (Bank / Airline / Ambassador / Pay-per-use lounges)
- Transit Hotels
- Hotel reservation counters
- Airport shuttle and transportation counters
- Car Rental
- Changi Recommends outlets and service counters
- Passenger meeting services counters
- Left luggage service counters
- Telecommunication outlets and service counters (e.g. M1)
- Temporary outposts
- Crowne Plaza Hotel (including all retail, F&B or service within the hotel premises) and YOTELAIR Singapore Changi Airport
- Tour and travel services
- Changi Experience Studio tickets
- Jewel attraction tickets
- Online purchases made in Jewel Changi Airport

The list of participating outlets in the Promotion is subject to change by CAG at its discretion without prior notice.

Shoppers who meet the qualifying spend in a receipt will be issued with a slip, which may take the form of (i) a bar-coded acknowledgement slip at the point of collection (for online purchases at iShopChangi); (ii) a bar-coded and QR-coded receipt; or (iii) chance card (for purchases made at Singapore Changi Airport and Jewel Changi Airport) (each referred to as "Draw Slip"). Each Draw Slip entitles the shopper to participate in the Lucky Draws described in Clause 5.

- 2.4 10x chances will be allocated to the Selected Shoppers. If a qualifying participant happens to be both a Changi Rewards member and who shopped on iShopChangi, 10x chances will be applied only once. The table below illustrates the chances for the following spending scenarios:

- 2.5 CAG reserves the right to disqualify any Draw Slip which does not meet the criteria set out in these T&Cs.

3. PRIZES

- 3.1 The following prizes have been allocated for the Promotion ("Prizes"):

3.1.1 **Instant Game:** An assortment of e-vouchers and products for redemption on iShopChangi or at participating tenants of Singapore Changi Airport and Jewel Changi Airport (all to be determined by CAG), on a while stocks last basis.

3.1.2 **Lucky Draws for Weekly Cash Prizes:** Lucky Draws will be conducted during the Promotion Period (Fridays – Thursdays, except for the last week of Promotion Period, which will be from 20 February to 29 February 2020) to select 52 weekly winners to win weekly cash prize of SGD10,000.

3.1.3 **Lucky Draw for Car Prize – One New All-Electric Jaguar I-PACE (6 finalists):** A Lucky Draw will be conducted after the end of the Promotion Period (on such date and at such venue as CAG may determine in its absolute discretion) to select 2 Changi Rewards members, 2 iShopChangi shoppers and 2 UnionPay Participants to participate in the Grand Draw for the Car Prize (as finalist for the Grand Draw for the Car Prize). Each finalist selected to participate in the Grand Draw for the Car Prize shall:

3.1.3.1 (where Singapore is not the finalist's country of residence) receive one (1) economy class return air ticket to Singapore from his/her country of residence to participate in the Grand Draw for the Car Prize;

3.1.3.2 receive a 3-night stay in a Singapore hotel chosen by CAG; and

3.1.3.3 (save for the winner of the Car Prize) receive a cash prize of SGD1,000.

All finalists selected to participate in the Grand Draw for the Car Prize shall: (a) be present in Singapore on such date and at such venue specified by CAG in order to participate in the Grand Draw for the Car Prize; and (b) (save as provided herein) bear all costs and expenses in relation to the Grand Draw for the Car Prize (including incidentals charges, applicable taxes, insurance, visas, out-of-pocket expenses, etc.).

3.1.4 **Lucky Draws for Grand Prize (12 finalists):** Monthly Lucky Draws will be conducted during the Promotion Period to select twelve (12) finalists to participate in the Grand Draw for the Grand Prize. Each finalist selected to participate in the Grand Draw for the Grand Prize shall:

3.1.4.1 (where Singapore is not the finalist's country of residence) receive one (1) economy class return air ticket to Singapore from his/her country of residence to participate in the Grand Draw for the Grand Prize;

3.1.4.2 receive a 3-night stay in a Singapore hotel chosen by CAG; and

3.1.4.3 (save for the winner of the Grand Prize) receive a cash prize of SGD5,000.

All finalists selected to participate in the Grand Draw for the Grand Prize shall: (a) be present in Singapore on such date and at such venue specified by CAG to participate in the Grand Draw for the Grand Prize; and (b) (save as provided herein) bear all costs and expenses in relation to the Grand Draw for the Grand Prize (including incidentals charges, applicable taxes, insurance, visas, out-of-pocket expenses, etc.).

3.1.5 Grand Prize - One (1) winner: Cash prize of SGD1,000,000.

3.1.6 Car Prize – One (1) winner: One New All-Electric Jaguar I-PACE.

3.1.7 Weekly Cash Prizes – 52 winners: SGD10,000

3.2 The Car Prize is inclusive of applicable goods and services tax (“GST”), but exclusive of Certificate of Entitlement (COE), Additional Registration Fee (ARF), Excise Duty, Road Tax, Number Plates, Radio License, Insurance and In-Vehicle Unit. Car colour is subject to availability. Specifications may vary from picture shown in our marketing and publicity collaterals/materials.

3.3 All Prizes are non-transferable, non-refundable and non-exchangeable for cash, credit, goods or benefits-in-kind, unless otherwise stated.

3.4 CAG may at any time and without notice in its sole and absolute discretion and without assigning any reason, substitute any Prize with any other item of a similar value.

3.5 CAG and Wearnes Automotive Pte. Ltd. make no representation, warranty or undertaking whatsoever as to any implied terms or conditions with respect to any Prize.

3.6 CAG shall not be responsible for any consequences, including but not limited to loss of life, injury to person and/or damage to property, arising from or in connection with the Promotion, the Lucky Draws and/or redemption or use of the Prizes.

3.7 The Car Prize winner shall present his/her NRIC or passport, together with the winning letter issued by CAG to redeem the Car Prize. The Car Prize must be redeemed within two (2) weeks of the Grand Draw for the Car Prize, and registered in Singapore within one (1) month of redeeming the Car Prize. Wearnes Automotive Pte. Ltd. will be the sole party facilitating the registration of the Car Prize for the Car Prize winner. The Car Prize winner shall pay for the prevailing COE and provide all necessary information and/or supporting documents for the purposes of registering the Car Prize by 31 July 2020 (or such other date as may be informed by CAG). If the Car Prize winner chooses not to register the Car Prize or if the Car Prize winner is a foreigner not residing in Singapore, the Car Prize winner may only sell the Car Prize to Wearnes Automotive Pte. Ltd for cash at a reasonable price as may be determined by Wearnes Automotive Pte. Ltd.

3.8 All other Prizes (save for the Car Prize) that remain unclaimed or unredeemed beyond 31 March 2020 shall be forfeited. Any participant whose Prize has been forfeited hereunder shall not be entitled to any payment or compensation. Failure to respond to any notification from CAG (in the manner as set out at Clause 5.8) in relation to any Prize won, or to provide any information or material required for the redemption/collection of any Prize, shall be deemed to be a failure to claim/ redeem such Prize and Clause 5.8 shall apply accordingly. CAG reserves the right to donate any unclaimed or unredeemed Prizes to charities of its choice.

4. INSTANT GAME

4.1 Shoppers can participate in the Instant Game through the self-service kiosk located at all terminals at Singapore Changi Airport, Jewel Changi Airport or online through the microsite (ishopchangi.com/millionaire) using the Draw Slip.

4.2 Shoppers can participate in the Instant Game on a day which is different from the date of their qualifying purchase as long as they participate during the Promotion Period.

4.3 CAG reserves the right to deny or claw back any Prize awarded to any winner should the winner subsequently be found to be disqualified or ineligible to participate in the Instant Game. CAG’s determination on all matters relating to the Instant Game shall be final, conclusive and binding. No correspondence will be entertained.

5. LUCKY DRAWS

5.1 Except for the Selected Shoppers, all other qualifying shoppers have to register their participation within the Promotion Period via their electronic devices or at the self-service kiosks at Singapore Changi Airport or Jewel Changi Airport using the Draw Slips

to enrol in the Lucky Draws. The Selected Shoppers will be automatically enrolled in the Lucky Draws in the month their qualifying spend was made. To qualify for the Lucky Draws, qualifying shoppers who register their participation via their electronic devices using the chance card must upload an image of their original qualifying spend receipt as part of their registration, while those who register their participation at the self-service kiosks must drop off their chance card, lucky draw participation form and original qualifying spend receipt at the Lucky Draw box located at the designated event areas on the same day of their registration.

- 5.2 **Weekly Cash Prize:** CAG will conduct 52 Weekly Lucky Draws to select 52 Weekly Cash Prize winners who will win SGD10,000 each.
- 5.3 **Grand Prize:** CAG will conduct 12 Monthly Lucky Draws to select finalists (the "**Grand Prize Finalists**") to participate in the Grand Draw for the Grand Prize. One (1) finalist will be drawn from each Monthly Lucky Draw (each Monthly Lucky Draw to be held once every calendar month during the Promotion Period).
- 5.4 **Car Prize:** CAG will conduct one (1) Lucky Draw at the end of the Promotion Period to select six (6) finalists (the "**Car Prize Finalists**") to participate in the Grand Draw for the Car Prize.
- 5.5 Accordingly, 18 finalists from the pool of Grand Prize Finalists and Car Prize Finalists will be invited to attend the Grand Draw event as described in Clause 6.
- 5.6 All Lucky Draws will be conducted at CAG's office in Terminal 2 at level 4. CAG reserves the right to change the location of the Lucky Draws without prior notice.
- 5.7 The Weekly Cash Prize Lucky Draws and the Monthly Lucky Draws will be conducted on the 4th working day of every calendar month, starting from 4 April 2019, for the Lucky Draw entries entered in the preceding month. The Monthly Lucky Draw for the Car Prize will be conducted on 5 March 2020. CAG reserves the right to change the date of any of the said lucky draws without notice.
- 5.8 All finalists will be notified in writing by email and/or phone using the details provided in the participating entries ("**Notification**"). To qualify, the finalists must respond in writing by email within five (5) calendar days from the date of the Notification, failing which they will automatically be disqualified and replaced with another finalist, who will be subject to the same notification procedures stated in this clause. Any notice given to a finalist shall be deemed sufficiently served if addressed to the finalist and sent by email to the respective email address provided in the participating entry.

6. GRAND DRAW

- 6.1 CAG will organise a Grand Draw to pick one (1) winner from the Grand Prize Finalists to receive the Grand Prize of SGD1,000,000 and one (1) winner from the Car Prize Finalists to receive the Car Prize.
- 6.2 The Grand Draw will take place on such date and at such time as may be determined by CAG. The exact date and time of the Grand Draw will be made known to all finalists no later than three (3) weeks before the Grand Draw date.
- 6.3 CAG, in its sole and absolute discretion, will determine the method of drawing the Grand Prize winner and Car Prize winner during the Grand Draw ceremony.
- 6.4 All participants acknowledge that the public disclosure of their names, cities/countries of residence and photographs, as well as their participation in advertising, media interviews and other promotion and marketing events may be required for carrying out the purposes of the Promotion. By participating in the Promotion, all participants agree to, and provide CAG consent for, the public disclosure of their names, cities/countries of residence and photographs for publicity or commercial purposes. All participants further agree to participate in any advertising, promotion, media interviews and publicity activities stipulated by CAG in relation to the Lucky Draws, and to provide and permit the use of any data and photographs of the participants for any future promotion/marketing efforts and media publicity by CAG. Accordingly, unless otherwise permitted by CAG, participants shall not during the Grand Draw or any publicity or promotion activities in connection therewith, wear, put on, or do any other thing which may, in the reasonable opinion of CAG, lead to the concealment of the participant's facial appearance and identity. Failure to comply with Clause 6.4 will result in disqualification and forfeiture of all prizes specified in Clauses 3.
- 6.5 Finalists who are unable to attend the Grand Draw in person for any reason (after confirmation of attendance) will forfeit their chance at the Grand Draw. In this regard, CAG will not accept any replacements nominated by the finalist to attend the Grand Draw. In addition, they will also forfeit all prizes specified in Clauses 3.1.5 and 3.1.6, and will not receive any reimbursement or compensation for any payment that may have been made by them in relation to the trip. CAG reserves the right to substitute any finalist subsequently found to be ineligible or disqualified with reserve finalists.

7 PAYMENT OF PRIZE MONEY

- 7.1 All winners of the cash prizes stipulated in Clauses 3.1.2, 3.1.5 and 3.1.7 above (“**Cash Prize Winners**”) are required to provide his/her bank account details (in his/her name) in writing for the prize money to be remitted. CAG bears no responsibility for inaccurate information provided by the Cash Prize Winners or any non-receipt of the prize money as a result of the inaccurate information provided by the Cash Prize Winners.
- 7.2 The value of the prize money shall be in Singapore Dollars and paid through telegraphic transfer for foreign Cash Prize Winners and by cheque for Singaporean Cash Prize Winners. The final amount received by foreign Cash Prize Winners may be subject to foreign currency exchange rate fluctuations.
- 7.3 Foreign Cash Prize Winners shall bear all bank processing fees and other bank charges imposed for the telegraphic transfer of the prize money.
- 7.4 All Cash Prize Winners shall be responsible for any applicable personal income taxes, custom fees, duties, fines, levies, assessments and other taxes payable in relation to the prize money under the laws of Singapore or of any other country, as the case may be. If CAG receives a request from any tax authority (whether local or overseas) to pay such taxes, fees, duties, fines, levies and/or assessments on behalf of the Cash Prize Winner, or to withhold payments to the Cash Prize Winner in order that CAG may subsequently so pay any of the abovementioned taxes, fees, duties, fines, levies and/or assessments, the Cash Prize Winner hereby authorises CAG to comply with the terms of such request.

8 GENERAL TERMS & CONDITIONS

- 8.1 CAG reserves the right to disqualify any participant who is found at any time (whether before or after the receipt of any prize) to be in breach of the eligibility criteria contained in Clause 1. Any prizes awarded will be forfeited, and if collected, shall be returned to CAG promptly.
- 8.2 CAG’s decision on all matters relating to the Promotion and/or Lucky Draws shall be final, conclusive and binding. No correspondence will be entertained.
- 8.3 CAG and its authorised agencies shall not be liable to any participant for any injury, damage, loss, cost or expense arising out of or in connection with the Promotion and/or Lucky Draws, and each participant agrees to indemnify and hold CAG harmless from and against any and all claims, damage, losses, costs or expenses suffered or incurred by CAG in relation to the Promotion and/or Lucky Draws.
- 8.4 CAG reserves the right to vary the T&Cs at any time at its absolute discretion without notice. In the event of any inconsistency between these T&Cs with any other form of publicity collaterals relating to the Promotion, these T&Cs shall prevail.
- 8.5 This Promotion, Lucky Draws and these T&Cs are governed by the laws of the Republic of Singapore. CAG and all participants hereby submit to the exclusive jurisdiction of the Singapore courts in the determination of any matter or dispute arising in connection therewith.
- 8.6 These T&Cs are not intended to confer rights to any third party under the Contracts (Rights of Third Parties) Act (Cap. 53B) to enforce any provision of these T&Cs, and the operation of the said Act is hereby excluded.
- 8.7 All participants acknowledge and agree that CAG will be permitted to collect the personal data of all participants for the purpose of the Promotion, Lucky Draws, statistical analyses, marketing and/or survey participation solely in respect of the Promotion (the “**Relevant Purposes**”). CAG may also disclose such personal data to any of its service providers and/or agents for the Relevant Purposes.
- 8.8 All participants acknowledge and agree that CAG may match the data collected through this Promotion with other data that CAG holds about the participant. This enables the optimising of operations and services offered to participants through the Promotion and other platforms, such as providing relevant and personalised content designed to make the user experience smoother and more enjoyable.
- 8.9 By participating in the Promotion, participants consent to the collection and use of the personal data by CAG as described above. Participants may contact CAG to request a copy of their personal data held by CAG, correct any inaccuracies in such personal data or object to the processing of their information where this is justified.
